UCP of San Diego provided programs and services to 2,542 individuals with disabilities, their families, care providers, special education college students, educators, and other professionals during the year. Within that total, we provided daily adult day and employment programs for 122 people on a daily basis, in home respite care for 8 families, served 429 people in our Assistive Technology Center, 549 children with disabilities and their families in the Toy and Software Lending Library.

Our funding programs assisted 29 low-income individuals with disabilities to acquire durable medical equipment, assistive technology equipment and other un-met needs of a last resort. We granted 76 parent couples resort hotel certificates from our Respite Program to give them a week-end getaway from the demanding care routines of their children with disabilities. We also recycled durable medical equipment such as wheelchairs, scooters, walkers, bath equipment, standers, and pediatric strollers to 56 people with disabilities.

UCP of San Diego provided training, information and referral services and advocacy to many more people with disabilities and their families throughout San Diego County.

UCP of San Diego has staff serving on numerous community efforts to improve the lives
